
Who Are We?

The Lightning Turtles are an engineering and design award-winning robotics team from Mendota Heights, MN, with 40+ diverse high school student members. We participate in FIRST (www.firstinspires.org), a worldwide robotics organization that includes thousands of teams and hundreds of thousands of students. Our robotics program encourages innovation with students and fosters well-rounded life skills -- including self-confidence, communication, and leadership. As a non-profit organization running a high-budget program, we rely on sponsor donations, both in-kind and cash, to continue the work we do.

FIRST - "A Sport for the Mind"

The FIRST Robotics Competition combines the excitement of sports with the rigors of science and technology. We teach, design and build robots yearround, but over a six week period in January/February, students design, manufacture, assemble, program, and test a robot to perform prescribed tasks against a field of competitors at regional competitions. It is as close to "real world" engineering as a high school student can get. And if we win at our regionals, we qualify for the World Championships held each April in Detroit, MI.
